POOL RULES

- 1. Hours of Operation: Daily from 10:00 a.m. to 8:00 p.m. during the scheduled Pool season.
- 2. Authorized Users: The Pools are for the exclusive use of property owners and their immediate family, and the tenants of non-resident property owners. Each property is allowed up to six guests per pool season. To be considered a family member for pool registration purposes, the individual must reside at the property for at least 3 weeks during the pool season and must have a permanent residence no closer than 50 miles from Savannah. If a property is more than 30 days past due, no one from that property will be allowed pool access until the account balance is fully paid. Violations of rules concerning the use of amenities or common areas may also lead to suspension of pool privileges.

3. Operational Guidelines:

- a. WARNING: NO LIFEGUARD ON DUTY. All participants swim at their own risk.
- b. All members and their guests must sign in at the pool gate when entering and check out at the gate when leaving. Guests must be accompanied by an adult GCSA member or tenant of a member. Guests cannot be members of the GCSA. Each household is limited to six (6) guests per season. You must show identification with proof of residency each time you come to the pool.
- c. Children 14 years of age and younger must be accompanied at all times by a parent or guardian that is at least twenty-one (21) years old. Solo swimming is prohibited. Parents or guardians are responsible for the actions and behavior of their children and the impact they have on other pool patrons.
- d. No one with infectious or communicable diseases is permitted in the pool. This includes those who have had diarrhea within the past 14 days. Those who have open blisters or cuts are warned of potential infection and are advised not to go into the pool.
- e. No pets allowed in the pool area.
- f. All swimmers must shower before entering the pool.
- g. No diving in the kiddie pool or in the shallow end of the main pool.
- h. No food of any kind is allowed in the pool or bathhouse area. Chewing gum, smoking/vaping, consuming alcoholic beverages, and bringing in glass containers are also prohibited activities. Clear water in plastic bottles is the only allowable beverage in the pool area.
- i. No littering. Please place trash in the receptacles provided.
- j. No spitting, spouting water, blowing nose in the pool, horseplay, running, breath-holding games, or foul language in the pool or pool area.
- k. The only floatation devices allowed in the pool are life jackets and other similar devices that are worn tight against the body. U.S. Coast Guard approved life jackets are the only devices of this type recommended by the Association, and only with close adult supervision. Non-connected pool noodles are authorized for use; however, rafts, floats, tubes, inflatable toys, inner tubes, and other floating devices are specifically not permitted.
- 1. Infants and toddlers three years old and younger, not potty trained, MUST wear snug fitting plastic pants or a water-resistant swim diaper when in the pool.

- m. Toys are not allowed in the pool as they may get sucked into the drains and damage the pool pumps and filters. There is also potential for personal injury if they are thrown.
- n. Music or other sounds from radios, cell phones, and other devices shall only be listened to via headphones. Cell phone conversations shall be discrete and not bother other pool patrons.
- o. Anyone under the influence of drugs or alcohol will be asked to leave.
- p. No swimming allowed during heavy rain or when thunder and lightning can be seen or heard.
- q. No sitting or lying on the mid-pool rope is allowed.
- r. Management reserves the right to immediate stop any unauthorized activity and may temporarily suspend the use of the facility in accordance with the Georgetown CSA Declarations of Covenants and Restrictions.
