AMENDMENT TO DECLARATION OF COVENANTS  
AND RESTRICTIONS FOR GEORGETOWN

KNOW ALL MEN BY THESE PRESENTS, that this Amendment to the Declaration of Covenants and Restrictions for Georgetown, said Declaration dated the 7th day of June, 1974, and recorded in Deed Book 103-W, Page <sup>207</sup> 837, in the Office of the Clerk of Superior Court of Chatham County, Georgia, is made on the date hereinafter set forth by Georgetown Associates, a limited partnership, and by: James H. Snooks Enterprises, Inc.; Walter C. Phillips Construction Co., Inc.; Alvin L. Davis, Inc.; Trinity Development Co.; Fred Williams Construction Company, Inc.; McCord Construction Co., Inc.; Kilpatrick-Smith Construction Co., Inc.; Remler & Burnsed Construction Co., Inc.; Scott Thompson Homes, Inc.; M. O. Lee Construction Co., Inc.; Bignault Builders, Inc.; Thaggard Construction Co., Inc.; and, Hugh H. Armstrong, Jr., S. Jerrell Brannen and Murray Stewart Marshall, d/b/a Armstrong, Brannen & Marshall Construction Co.; Moore Homes, Inc. and Ronald Davis Construction, Inc.

WHEREAS, the property which was encumbered by the aforementioned Declaration was described in Exhibit "A" attached to said Declaration; and,

WHEREAS, it is the intention of Georgetown Associates to develop portions of the property described in said Exhibit "A" for industrial, commercial and professional purposes; and,

WHEREAS, the parties hereto are all of the owners of the property described in said Exhibit "A" and now desire to amend said Declaration to permit the Board of Directors of the Georgetown Community Services Association to exclude from the property covered by the Declaration those portions thereof which are to be used for commercial, professional or industrial purposes;

NOW THEREFORE, for and in consideration of the foregoing recitals and to better carry out the purposes of the Declaration,

said Declaration is hereby amended by adding the following new section to Article II thereof, to be designated as Section 4:

"Section 4. Exclusions from Property Subject to Declaration. The Board of Directors shall have the right, by majority vote of all of the members thereof, to exclude from the property made subject to this Declaration any portion or portions thereof which shall be zoned for commercial, professional or industrial purposes."

Except as otherwise hereby specifically amended said Declaration shall remain in full force and effect.
